## DOWNTOWN ROADWORK EXPECTED TO START IN APRIL

Downtown roadwork is expected to begin the week of April 12th. This estimated date, like all others, depends on the weather.

The upcoming second phase of construction will focus on Judd Street south of Maple, and Maple west of Judd. Pavement will be removed and storm pipe will be

installed. Street base work is expected to take place through May. In May and June, curb, sidewalk, and a first layer of pavement will be installed on Judd Street south of Maple, and Maple west of Judd.

The final layer of pavement along with striping is slated for mid-July into early August.

The Library is pleased to announce that we are going to re-open our doors to limited, masked browsing and a chance to check out Washington County library books inside the library. We will be open weekly on Tuesday and Friday from 4 to 7 pm and Saturday 9 to noon for browsing, according to safety protocols. We will continue our Saturday morning curbside pick-up day.

## Here are the key procedures to allow this:

- One family unit will be allowed in at a time, assuming all members feel well and are masked.
- Browsers will be limited

to 15 minutes, unless there is no one waiting to come in, and the time can be extended.

• Patrons who are merely checking out their Washington County requests may come in one at a time while there are browsers since the books and check out computer are right inside the door. Library patrons can follow these browsing guidelines and visit during open hours.

Saturday morning from 10:30-12:00 will remain the only time to pick up curbside book requests, as has been occurring since last May.

## CITY OF MARINE DEFENDS SHORT-TERM RENTAL ORDINANCE

A Marine property owner, John P. Norusis, has sued the City challenging the City's recent adoption of a Short-Term Rental Licensing ("STR") Ordinance.

The City adopted the STR Ordinance after a lengthy process, which involved a substantial amount of public participation and comment, and is consistent with the regulations of other municipalities.

Paul Reuvers, through the League of Minnesota Cities Insurance Trust, is defending the City in this litigation, along with City Attorney David Snyder. Norusis sought a preliminary injunction to preclude enforcement of the STR Ordinance, which Chief Judge Douglas B. Meslow denied in an Order and Memorandum, dated December 23, 2020.

Significantly, the Court found Norusis was not likely to succeed on the merits.

The City will continue to vigorously defend the STR Ordinance and fully expects to prevail in this matter. The litigation process could take a year, or more, to complete.

## MARINE SAYS 'FAREWELL' TO FAIR

It's the end of an era for Marine's annual art fair.

On January 7, Fire Chief Dan Malmgren told the Marine City Council that Marine Fire & Rescue had decided to move in a different direction for future fundraising.

Although some type of event is expected to take the art fair's place, no announcement has been made about what it will be.

The annual street dance will continue. This year it is slated for fall.

### PHASE ONE OF JACKSON MEADOW LAND RESTORATION IS IN THE BOOKS

Conditions could not have been better this winter for volunteer and contractor work to restore a remnant prairie in the north meadow parkland located at the north end of the Jackson Meadow neighborhood. With frost in the ground and a thin snowpack starting in mid-December Landbridge Ecological was able to mechanically remove woody species to achieve the ecological goal of making room for ancient plant cultures on the site.

From November to mid-January more than 500 hours of volunteer time was donated by more than a dozen resi-

dence. Activities included tree felling, hauling and burning in support of the contractor. With a two-and-a-half-year timeframe - contract oversight will continue in cooperation between the Jackson Meadow Open Space Committee and city staff into the fall of 2022.

The restoration has been funded by a MN DNR Conservation Partners Legacy grant. Spring and summer will bring planting efforts throughout the site, with a planned prairie burn in the fall. Stay tuned for future volunteer opportunities.

## 2021 Marks the Second Year of The Old Shed Project

The Old Shed Project is a historic preservation, grant award program designed by Wendy Ward. This program aims to incentivize and assist Marine on St Croix residents with the rehabilitation of the many, unique outbuildings in our historic

When neighborhoods are walked, you may see old barns, old privies, blacksmithing shops, garden or tool sheds, chicken coops, small garages, animal shelters, and other small, tucked away, vernacular buildings. These simple outbuildings served as workshops, shelters and storage areas that were once vital parts of homesteads, places to do critical life chores. A typical homestead would have 1-4 of these structures. As a community we are losing these defining buildings to demolition, replacement and neglect. Maintaining and keeping these distinct, small buildings helps keeps Marine Ma-

With many Marine homeowners prioritizing home maintenance, the Old Shed Project wants to give Marine homeowners the incentive, the knowledge and the ability to start the rehabilitation of an in-need outbuilding. The Old Shed Project aims to make it easier for homeowners to undertake historic preservation work on their property.

Chapter 29 of the City Code outlines the use of trails within the City of Marine.

## Keep an eye out for **temporary signs**

about types of travel or modes of transport not allowed. For example, bicycles or horses may be temporarily prohibited due to conditions.



BYOPB (poop bag) and

## clean up after your dog.

It's considerate, *and* it's required by Chapter 5, Subd. 6 of the City Code.

Finish the job by bringing the bag to a trash can rather than leaving filled bags on the ground.

### COMPOST SITE

Tentatively, the city is planning to open the compost site in mid April.

Keep an eye out for postings, should the date change due to circumstances such as weather.

#### **HOURS**

Wednesdays noon to 7pm

**Saturdays** 9am to 2pm

- **OK to bring:** leaves, grass, and twigs under four inches.
- No sticks or brush.
- No garbage bags. Please take paper and plastic bags home with you.
- No trash. Please keep all glass, metals and plastics out of the compost.
- As always, the compost site will close during inclement weather.

#### Burn Permits

#### PLANNING A BONFIRE?

You must obtain a permit before burning any pile larger than 3x3 — campfire size.

Spring burning restrictions are currently in flux, so check the DNR burning permit page (dnr.state.mn.us/forestry/fire/questions.html) or call the city office for the latest.

When spring burning restrictions are in effect, no burn permits will be issued without a variance from the DNR. However, 3x3 recreational fires are still permitted.

Once restrictions are lifted, you must obtain a permit from the city office before burning any pile larger than 3x3—campfire size.

#### **How to Get a Permit**

To obtain a permit, contact the City

office during regular business hours Monday through Thursday.

The cost per permit is \$5.00 for piles or \$15.00 for a prescribed burn permit. Each permit is good for up to 3 consecutive days. Burning must take place between 6pm — 8am.

The permit holder must check with the Department of Natural Resources for current restrictions at www.dnr.state.mn.us/forestry/fire/firerating\_restrictions.html

#### City Council Recap

#### Street Dance Slated for Fall

Marine's annual Firefighter's Street Dance fundraiser will likely be held in the fall this year rather than June. With vaccinations currently underway for Covid-19, Marine Fire Chief Dan Malmgren told the city council in March that he expected more participation at a fall event.

#### No July Fireworks in 2021

A 3<sup>rd</sup> of July fireworks celebration will not happen in Marine for 2021, the city council decided in February. Ongoing concerns about Covid-19 make planning a high-turnout event difficult, even with vaccinations underway. However, plans are in the works for a parade similar to the one held in 2020. The council expressed optimism that fireworks would return in 2022.

#### **Cemetery Prices Increase**

Price increases were approved March 11 for lots and services at Marine's Oakland Cemetery. Residents will now pay \$800 per lot. Nonresidents will pay \$1,500. Full details on pricing are listed on the city's website: marineonstcroix.org/cemetery.

## **Protecting the Night With Dark-Sky Friendly Lighting**

What can you do to protect the darkness that pollinators, migratory birds, nocturnal animals, plants and people need for life and health while satisfying your lighting needs?

The specific purpose for lighting will guide your decision, but as a general rule, consider the following for dark-sky friendly lighting:

- Choose a shielded outdoor lighting fixture that directs light toward the ground. (See photos below.)
- Use a low wattage (20-40-watt) light bulb when that can be safely done.
- If you have a choice, chose a "warm" colored light bulb, which gives off less damaging blue light (learn more about the problem of blue light at https://www.darksky.org/why-is-blue-light-at-night-bad/).
- Turn off lights when you go to bed. If you need lighting for

someone coming home late at night, consider a motion sensor light or a programmable light switch (starting around \$25) that you can set to turn off at a predetermined time. You'll save money, too!

#### Watershed District Update

### CHECK IN WITH THE WATERSHED DISTRICT

The Carnelian Marine St. Croix Watershed District (CMSCWD) was formed by petition from citizens of the area in 1981 who wanted to ensure the long-term quality of natural resources in Northern Washington County.

Forty years later, the Watershed District's work with local landowners through voluntary conservation and permitting of construction and landscaping projects following water quality protection rules have helped maintain low concentrations of algaegrowing phosphorus and protects high water clarity. In fact, CMSCWD has some of the highest quality waters in the metro area which support high property values.

Contacting CMSCWCD's specialized staff can save you time and money planning your project and can also provide guidance on eligibility for cost share.
